PUBLIC OUTREACH

In addition to disseminating research findings to the academic community, my communication strategy commits to reaching out to non-academic audiences.

First, I am interested in exchanging information and ideas with relevant actors from civil society and politics. Amongst others, I have co-organized events with the Swiss Embassy in Berlin, the Protestant Academy in Tutzing, and the Bundesnetzwerk Bürgerschaftliches Engagement BBE (the largest civil society network in Germany).
